Previous minutes

1. The minutes of 17 January 2023 were agreed.

Business Programme

2. The Bureau considered and agreed to propose to the Parliament a revised programme of business for the week commencing 23 January. The Bureau also considered a programme of business for the weeks commencing 30 January and 6 February 2023.
3. Rhoda Grant noted that her view was that the Parliament should not meet on 1 February due to industrial action planned for that day. After discussion, the Bureau agreed to recommend a programme of business for the week commencing 30 January that included business on 1 February. Rhoda Grant reserved her position.
4. Clarification was sought about the circulation of the motion for one of the Scottish Conservative and Unionist Party debates on Wednesday 25 January, and the deadline for amendments to the motion. It was confirmed that the delay in circulation of the motion was due to consideration of sub judice issues and that an extended deadline would be allowed for amendments to be lodged.
5. The Minister for Parliamentary Business noted that information about the subject matter of the debate appeared to have been provided to stakeholders before other parties were made aware and questioned whether this was consistent with the requirements that apply to Scottish Government business.
6. The Bureau also agreed to recommend to the Parliament that Rule 15.2.1 of Standing Orders, which provides for access to the public galleries during meetings of the Parliament and committees, be suspended on 1 February 2023. This was in connection to industrial action planned for that day and the availability of staff to ensure the safety of building users. Rhoda Grant and Gillian Mackay reserved their positions.
7. The Bureau agreed that Members' Business on Tuesday 31 January would be Motion S6M-07290: Siobhian Brown: Concern Regarding Youth Vaping, on Wednesday 01 February Motion S6M-07161: Paul McLennan: Heart Month and on Thursday 02 February Motion S6M-06112: Sue Webber: Scottish Government Commissioned Review of ME Services and Future Action.

Referral of a Bill at Stage 1

8. The Bureau agreed to recommend to the Parliament that the Education, Children and Young People Committee be designated as the lead committee

and the Criminal Justice Committee be designated as secondary committee for the Children (Care and Justice) (Scotland) Bill.

Approval of SSIs

9. The Bureau noted that motions to approve the following would be lodged—

 - Dentists, Dental Care Professionals, Nurses, Nursing Associates and Midwives (International Registrations) Order 2022 (SI 2022/Draft)
10. Alexander Burnett and Rhoda Grant reserved their positions on the Land and Buildings Transaction Tax (additional amount: transactions relating to second homes etc.) (Scotland) Amendment Order 2022 (SSI 2022/375).

Commissioner for Ethical Standards in Public Life in Scotland - Appointment of a New Commissioner

11. The Bureau agreed to a motion being laid to appoint a new Commissioner for Ethical Standards in Public Life in Scotland and that it would be debated on 26 January 2023.
